Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minus) n the Rs. 9.00 crore bank facilities of Panchamrut Properties Private Limited (PPPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Incorporated in 2002, the Gujarat-based Panchamrut Properties Private Limited (PPPL) was promoted by Mr. Patel and family. The company has leased its school and campus at Anand, Gujarat to Jay Jalaram Education Trust (JJET) for 10 years with a five-year lock-in period.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
