Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 9.50 crore bank facilities of Sree Lakshminarasimha electricals. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Sree Lakshminarasimha Electricals was established in the year 1992 by Mr. Narasimhamurthy. The firm is a government licensed super grade electric contractor based at Tumkur, Karnataka. SLE has been successfully undertaking and executing HT, LT Installation i.e. design, engineering of Electrical Works in Substations, Overhead Lines, Commercial Complexes, Apartments, Educational Institutions, IT Parks, Hotels & Resorts, Office Interiors, Hospitals, Religious Institutions, Group Housing Projects, B.D.A. Work BESCOM and HESCOM works.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain.
