### Rating Rationale

SMERA has placed the long-term rating of '**SMERA B**' (read as **SMERA B**) and short term rating of '**SMERA A4**' (read as **SMERA A Four**) on the Rs.45.00 crore bank facilities of Sugna Metal Limited (SML) under notice of withdrawal. As per SMERA's 'Policy on Withdrawal of Ratings' the rating will be withdrawn after 90 days from the date of this release. SMERA has received a "No Objection Certificate" from the banker of SML and a request from the client in this regard.

### About the Rated Entity

Sugna Metals Limited (SML) was established on October 2006 by Mr. Bharat Kumar Sonthalia, Ms. Saroj Devi Santhalia and Mr. Mudit Santhalia as a private limited company and converted into a limited company in 2013. The company commenced operations from December 2008 to manufacture and trade in TMT Bars, MS Billets and other steel rolled products. The installed capacity stands at 200 MT per day for MS Billets and TMT bars each in Andhra Pradesh.

The company reported Profit after tax (PAT) of Rs 7.77 crore on operating income of Rs 268.36 crore in FY2015-16 as against PAT of Rs 5.35 crore on operating income of Rs 209.58 crore in FY2014-15.
