SBIW Steels Private Limited (SBIW) was established in 2006 by Mr. Jagdish P Goel and family. The company manufactures TMT bars on job work basis for SAIL at Durgapur, West Bengal. The installed capacity stands at 72,000 MT per annum.

SBIW reported profit after tax (PAT) of Rs.1.47 crore on operating income of Rs.20.30 crore for FY2014-15, as compared with PAT of Rs.1.36 crore on operating income of Rs.17.29 crore in FY2013-14.
