Acuité has reviewed long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 6.60 crore bank facilities of Union Steels. This rating is now an indicative rating and is based on best available information.

The Kerala-based Union Steels, a proprietorship concern was established in 2007 by Mr. Madhu Bansal. The firm trades in steel products such as pipes, fittings, non-ferrous items among others.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
