Acuite has reviewed the long-term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) on the Rs.10.00 crore bank facilities of Balaji Associates (BA). This rating is now an indicative rating and is based on best available information.

BA is a Tamil Nadu based partnership firm established in the year 2011 forming part of Prabhat Group of Companies. The partners of the firm are Mr. Jithendra D. Patel and Mr. Dalsuk D. Patel. The firm engaged in trading and processing of imported timbers. It also provides wood planning and sizing services to local firms situated in Trichy.

For FY2014-15, Balaji Associates reported profit after tax (PAT) of Rs.0.84 crore on operating income of Rs.113.46 crore, as compared with PAT of Rs.0.49 crore on operating income of Rs.96.12 crore for FY2013-2014

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
