Acuité has downgraded the long term rating to '**ACUITE B** (**read as ACUITE B**) and short term rating to '**ACUITE A4** (**read as ACUITE A four**) on the Rs. 7.50 crore bank facilities J. C. Fenasia Exports Private Limited (JCFE). The rating continues to be flagged as "Issuer Not-Cooperating".

JCFE, established in 2005 by Mr. Naresh Kumar Juneja, is engaged in the trading of finished leather sheets, raw hide and manufacturing of leather bags, wallets at Kasba (West Bengal). The company is promoted by Mr. Naresh Kumar Juneja and Ms. Minnie Juneja.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
