Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE C**’ (read as **ACUITE Co**) on the Rs.20.41 crore bank facilities of S S B Engineers Private Limited. The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

Incorporated in 1995, S S B Engineers Private Limited is a Rajasthan-based company led by its Directors, Mr. Deven Bhatia and Mr. Ram Bhatia. The company is engaged in manufacturing of various forged, rolled, machined parts and other auto components such as bearing cup, bearing con, bars, rings. The total installed capacity stands at 16000 tons per annum, of which the company utilises around 85 per cent. It has a reputed clientele which includes Timken India Limited, Carraro group, Ashok Leyland and Graziano Transmission India Private Limited, to name a few.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
