Acuite has downgraded the long term rating to '**ACUITE B+**' (read as **ACUITE B plus**) from '**ACUITE BB-**' (read as **ACUITE double B minus**) and the short-term rating to '**ACUITE A4**' (read as **ACUITE A four**) from '**ACUITE A4+**'

(read as **ACUITE A four plus**) on the Rs. 14.75 crore bank facilities of V R Constructions (VRC). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

VRC, a civil construction firm established in 1999 based in Nellore, Andhra Pradesh by Mr. G. Raja Shekhara Rao, Mr. M Ravi Kumar and Mr. G. Lakshmi Rajyam, undertakes construction of road, canals and drainage activity for the government.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
