Rating Rationale

Acuite has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) on the Rs. 15.00 crore bank facilities of Avmark Polymers Private Limited (APPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

The Kanpur based Avmark Polymers Private Limited , promoted by Mr. Gaurav Agarwal, Saurabh Agarwal and Mr. Prateek Arora in 2013, is engaged in the production of tarpaulin.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
