SMERA has reviewed the long term rating of '**SMERA BB-**' (read as **SMERA double B minus**) and short term rating of '**SMERA A4+**' (read as **SMERA A four plus**) on the Rs.10.00 crore bank facilities of Sinex Systems Private Limited. This rating is now an indicative rating and is based on best available information.

**Non-cooperation by the issuer/borrower:** SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

**About the Rated Entity:** SSPL was established in 1995 under the directorship of Mr. Badri Narayanan and Mrs. Varalakshmi Badri Naryanan. The company manufactures displays, signages and stretch ceilings (under the brand name Euroceil).

For FY2014-15, SSPL reported profit after tax (PAT) of Rs.0.53 crore on operating income of Rs.16.75 crore, as compared with profit after tax (PAT) of Rs. 0.18 crore on operating income of Rs. 12.88 crore in FY2013-14.
