Acuité has reviewed long-term rating of '**ACUITE BB**' (read as **ACUITE double B**) and the short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 15.00 crore bank facilities of Sinex Systems Private Limited (SSPL). This rating is now an indicative rating and is based on best available information.

The Chennai-based SSPL, established in 1995 by Mr. Badri Narayanan and Mrs. Varalakshmi Badri Naryanan, is engaged in the manufacturing of signages, displays and stretch ceilings under the Euroceil brand name.

Non-cooperation by the issuer/borrower
