Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.15.00 crore bank facilities of Sinex Systems Private Limited (SSPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

The Chennai-based Sinex Systems Private Limited (SSPL), established in 1995 by Mr. Badri Narayanan and Mrs. Varalakshmi Badri Naryanan, is engaged in the manufacturing of signages, displays and stretch ceilings under the Euroceil brand name.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
