Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE B-’** (read as **ACUITE B Minus**) and short-term rating of ‘**ACUITE A4’** (read as **ACUITE A four**) on the Rs. 8.48 crore bank facilities of Annapurna Traders. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Annapurna Traders was incorporated in 2003 by Mr. Ranidan Gilda. Currently, the overall operations of the firm are looked after by Mr. Manish Gilda. The firm is engaged in the milling of non-basmati rice and wheat and has two manufacturing units in Bematra and Nandul, Chattisgarh.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
