Rating Rationale

Acuite has downgraded the long term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) and reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 8.00 crore bank facilities of Vipin Shah and Associates on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Vipin Shah and Associates established in 1996 by Mr. Vipin Shah, is a Mumbai based company engaged in the business of civil construction and executes turnkey projects. The proprietor, a civil engineer, possesses an experience of over two decades in the said line of business.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
