Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE Da)nd short-term rating of 'ACUITE D' (read as ACUITE Do) n the Rs. 14.90 crore bank facilities of Bostin Engineers Private Limited (BEPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.
