Acuité has reviewed the long-term rating of '**ACUITE B+** (read as **ACUITE Single B plus**) and short term rating of '**ACUITE A4** (read as **ACUITE A four**) on the Rs.7.64 crore bank facilities of Surya Prakaas Foundry. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Surya Prakaas Foundry (SPF), a proprietorship concern was established in 2003 by Mr. M. Kanagarajan. The Tamil Nadu-based firm is engaged in the manufacturing of castings and has an installed capacity of 2400 MT per annum. Mr Kanagarajan has more than two decades of experience in the business. For FY2014-15, SPF reported profit after tax (PAT) of Rs.0.50 crore on operating income of Rs.13.04 crore compared with PAT of Rs.0.28 crore on operating income of Rs.6.01 crore in the previous year.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
