Acuité has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 8.50 crore bank facilities of Signet Garments Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Signet Garments Private Limited (SGPL), a New Delhi-based was incorporated in 2004 by by Mr. Rahul Chawla who possesses experience of over a decade in the garments and apparels industry. The company is engaged in the manufacture and export of readymade fashion garments for women, men and children. The manufacturing facility is located at Ghaziabad and has an installed capacity of 10 lakh pieces per annum.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
