Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs 5.50 crore bank facilities of Hitech Engineers and Infra Developers. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Hitech Engineers and Infra Developers is a Chennai-based proprietorship firm established in the year 1995 that undertakes civil contracts for commercial as well as residential projects. The firm has executed various projects (roads, bridges, commercial and residential buildings) for private entities. Hitech Engineers and Infra Developers is promoted by Mr. Thiagarajan who possesses around three decades of experience in civil construction.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
