Acuité has reviewed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) and short term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 68.50 crore bank facilities of Paras Bhavani Steel Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Paras Bhavani Steel Private Limited was incorporated in 2007 by Mr. Parasmal Bohra. The company is engaged in the business of manufacturing of steel pipes, hollow sections, tubes, cold -rolled coils and strips and a variety of other galvanized products at Ahmedabad.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
