Acuité has reviewed long-term rating of '**ACUITE BB-**' (**read as ACUITE double B minus**) and short term rating of '**ACUITE A4+**' (**read as 'ACUITE A four plus**) on the Rs. 15.00 crore bank facilities of C. Parkashan & Co. (CPC). This rating is now an indicative rating and is based on best available information.

CPC, a civil construction firm was established by Mr. Suraj Bhan Goel in 1974. The firm undertakes Engineering, Procurement and Construction (EPC) contracts mainly for the Public Works Department (PWD), Municipal Corporation of Delhi (MCD), Delhi and NCR region for construction and maintenance of roads. The firm is led by Mr. Chand Prakash Goel (son of Mr. S.B. Goel) and Mr. Sachin Goel (son of Mr. C.P. Goel)

#### Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
