SMERA has reviewed long-term rating of '**SMERA BB** (read as SMERA BB) and short term rating of '**SMERA A4+** (read as 'SMERA A four plus') on the Rs. 11.30 crore bank facilities of Multiurban Infra Services Private Limited. This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower

SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

Multiurban Infra Services Private Limited (MISPL), incorporated in 2007, is a Nagpur based company that undertakes turnkey projects related to water supply and maintenance. The company is headed by Mr. Praveen Rander (Director). MISPL is located in Maharashtra and plans to spread operations to Madhya Pradesh, Uttar Pradesh and Chhattisgarh. The company caters to government as well as private entities.

MISPL reported PAT (profit after tax) of Rs. 0.86 crore on operating income of Rs. 16.02 crore for FY2014-15, compared with PAT (profit after tax) of Rs.0.69 crore on operating income of Rs.12.98 crore in the previous year.
