Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B' (read as ACUITE B) on the Rs. 7.50 crore bank facilities of Reva (Sunil) Education Society (RES). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

RES (registered under M.P. Society Registration Act, 1973) was established in 2015. It is a non-profit organization that has set up a CBSE affiliated co-educational school under the 'Saket International School' name in Barwani, Madhya Pradesh. The society is promoted by Mr. Sunil Patidar, Mr. Sunil Dora, Mr. Narendra Kumar Gole and Mr. Ishwar Patidar.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
