Acuité has reviewed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and short term rating of '**ACUITE A4**' (read as '**ACUITE A four**') on the Rs. 7.55crore bank facilities of Sree Jeyasakthi saw mill. This rating is now an indicative rating and is based on best available information.

Sree Jeyasakthi Saw Mill (SJSJ), a partnership firm was established in 2002 by Mr. Sanjeev Kumar. The firm imports and trades in timber. Timber is imported from Singapore, Australia and South Africa. For FY2014-15, SJSJ has reported PAT of Rs.0.08 crore on operating income of Rs.7.73 crore as against (Profit after Tax) PAT of Rs.0.06 crore on operating income of Rs.10.82 crore in the previous year.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
