

Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minus) and the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 7.55 crore bank facilities of Sree Jeya sakthi Saw Mill. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Tamil Nadu based Sree Jeyasakthi Saw Mill (SJSM), a partnership firm was established in 2002 by Mr. Sanjeev Kumar. The firm imports and trades in timber. Timber is imported from Singapore, Australia and South Africa. For FY2014-15, SJSM has reported PAT of Rs.0.08 crore on operating income of Rs.7.73 crore as against (Profit after Tax) PAT of Rs.0.06 crore on operating income of Rs.10.82 crore in the previous year

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
