Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minusa)nd the short-term rating of 'ACUITE A4' (read as ACUITE A four)on the Rs. 7.55 crore bank facilities of Sree Jeyasakthi Saw Mill. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Tamil Nadu based Sree Jeyasakthi Saw Mill (SJSM), a partnership firm was established in 2002 by Mr. Sanjeev Kumar. The firm imports and trades in timber. Timber is imported from Singapore, Australia and South Africa.

#### Non-cooperation by the issuer/borrower:
