Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 8.00 crore bank facilities of Giriraj Cotex Ginning & Pressing (GCGP). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Established in 2014, Giriraj Cotex Ginning & Pressing (GCGP) is a partnership firm promoted by Mr. Rajesh M Vyas and family, based out of Wardha, Maharashtra. The firm is engaged in manufacturing of cotton bales and cotton seeds. It launched commercial operations in October, 2015. The factory unit is located in proximity of cotton growing areas in Wardha and has the capacity to manufacture 240 cotton bales per day. The present partners of the firm are Mr. Vinod Kumar M Vyas, Mr. Gaurav R Vyas, Mr. Madhav R Vyas, Mr. Rajesh M Vyas and Mr. Shubham V Vyas.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions

lenders and investors regarding the use of such information, on which the indicative credit rating is based.
