Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE D' (read as ACUITE D)** on the Rs. 10.50 crore bank facilities of Keshav Khanak Seeds Private Limited (KKSPL). This rating is now an indicative rating and is based on best available information.

Keshav Khanak Seeds Private Limited was incorporated in 2011 as a private limited company by Mr. Satpal Keshavdas Hassani and Mrs Kesar Satpal Hassani. Company is engaged in the business of processing and trading of paddy seeds.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
