**The issuer did not co-operate; based on best available information.

Acuite has reviewed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs.10.50 crore bank facilities of Keshav Khanak Seeds Private Limited (KKSPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Incorporated in 2011, KKSPL, a Nagpur-based company was promoted by Mr. Satpal Keshav das Hassani and Mrs. Kesar Satpal Hassani. The company is engaged in the processing and trading of paddy seeds and has an installed capacity of 48 metric tons per day. The company sells its products under the brand name of 'Keshav Khanak' in Chhattisgarh, Madhya Pradesh, Maharashtra, Uttar Pradesh and Bihar

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
