Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE D' (read as ACUITE D)** on the Rs.10.50 crore bank facilities of Keshav Khanak Seeds Private Limited (KKSPL). The rating continues to be flagged as "Issuer NotCooperating" and is based on the best available information.

About the Company

Incorporated in 2011, Keshav Khanak Seeds Private Limited (KKSPL), a Nagpur-based company was promoted by Mr. Satpal Keshavdas Hassani and Mrs. Kesar Satpal Hassani. The company is engaged in the processing and trading of paddy seeds and has an installed capacity of 48 metric tons per day. The company sells its products under the brand name of 'Keshav Khanak' in Chhattisgarh, Madhya Pradesh, Maharashtra, Uttar Pradesh and Bihar.

Non-cooperation by the issuer/borrower:
