Acuité has reviewed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 5.60 crore bank facilities of G.K. Roofings (India) Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Chennai based - G.K.Roofings India Private Limited (GKRIPL), incorporated in 2003 by Mr.G.Kannappa Mudaliar, Mr.K.Govindarajan and Mr.K.Parthiban. The company is engaged in the manufacturing and trading of Steel roofing sheets.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
