Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 5.60 crore bank facilities of G.K. Roofings (India) Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Chennai based - G.K.Roofings India Private Limited (GKRIPL), incorporated in 2003 by Mr. G.Kannappa Mudaliar, Mr. K.Govindarajan and Mr. K.Parthiban. The company is engaged in the manufacturing and trading of Steel roofing sheets.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
