

## Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minus) and short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 5.60 crore bank facilities of G.K. Roofings (India) Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

# **About the Company**

Chennai based - G.K.Roofings India Private Limited (GKRIPL), incorporated in 2003 by Mr. G.Kannappa Mudaliar, Mr. K.Govindarajan and Mr. K.Parthiban. The company is engaged in the manufacturing and trading of Steel roofing sheets.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
