**Rating Rationale**

Acuite has reaffirmed the long-term rating of ‘**ACUITE B-**’ (read as **ACUITE B minus**) and short term rating of ‘**ACUITE A4**’ (read as **ACUITE A four**) on the Rs. 5.60 crore bank facilities of G K ROOFINGS INDIA PRIVATE LIMITED (GKRIPL). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

Chennai based - G K ROOFINGS INDIA PRIVATE LIMITED (GKRIPL), incorporated in 2003 by Mr. G.Kannappa Mudaliar, Mr. K.Govindarajan and Mr. K.Parthiban. The company is engaged in the manufacturing and trading of Steel roofing sheets.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
