Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) and the short term rating of ‘**ACUITE D**’ (read as **ACUITE Do**) on the Rs. 48.27 crore bank facilities of Sapphire Digital Printers (SDP). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

The Haryana based-Sapphire Digital Printers (SDP) is a proprietorship firm established in 2003 by Mr. Neeraj Chaudhary. SDP is engaged in the business of digital printing, publishing of books, brochures, posters, wedding albums and wedding cards at Gurgaon. SDP has two manufacturing units in Haryana.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
