**Rating Rationale**

Acuite has downgraded the long-term rating to ‘**ACUITE B**’ (read as **ACUITE B**) from ‘**ACUITE B+**’ (read as **ACUITE B plus**) on the Rs. 5.50 crore bank facilities of Geonet It Mall on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

**About the Company**

Established in 2006, Geonet IT Mall (GIM), is a proprietorship firm was promoted by Mrs. Suneetapriya Singh. The firm has several HP World stores (Brand Exclusive) in 16 cities of Maharashtra including Mumbai, NaviMumbai, Thane, Pune among others. The day-to-day operations are managed by Mrs. Suneetapriya Singh and Mr. Bimal Kumar Singh (CEO).

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
