Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs.17.50 crore bank facilities of Varad Fertilisers Private Limited (VFPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

VFPL, incorporated in 1991 is Maharashtra-based company engaged in manufacturing of fertilisers and trading of seeds. The day to day activities are managed by its directors, Mr. Vidyaprakash Onkarlal Agrawal, Mr. Ram Niwas Jagannath Mandhani, Mr. Gopal Motilal Mandhani, Mr. Chandraprakash Lalchand Madhani and Mr. Sanjay Sarda. The company has installed capacity of 100 metric tonnes per day of NPK Fertilizers and 1500 liters per day of bio fertilizers.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
