Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 11.25 crore bank facilities of Arasu Jewels. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Arasu Jewels, incorporated in 2009, is a Chennai-based company promoted by Mr. Vamsikrishna Veluru and Mr. Aallan Paul. It is engaged in the trading of agro based and sea food products.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
