

### Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B' (read as ACUITE B) on the Rs. 11.25 crore bank facilities of Arasu Jewels. The rating continues to be flagged as "Issuer NotCooperating" and is based on the best available information.

## **About the Company**

Arasu Jewels, incorporated in 2009, is a Chennai-based company promoted by Mr. VamsikrishnaVeluru and Mr. Aallan Paul. It is engaged in the trading of agro based and sea food products.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

### Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain.
