Rating Rationale

Acuite has downgraded the long-term rating to ‘ACUITE B’ (read as ACUITE Bf) from ‘ACUITE B+’ (read as ACUITE B plus) and reaffirmed the short term rating of ‘ACUITE A4’ (read as ACUITE A four) on the Rs. 10.00 Crore bank facilities of Deccan Engineering Constructions Private Limited (DECPL) on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Deccan Engineering Constructions Private Limited, a Chennai-based civil construction company undertakes construction projects for Central Public Works Department (CPWD) in Tamil Nadu. Deccan Engineering Constructions Private Limited is incorporated on August 1931 and promoter is Mr. V. V. D. Murli.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
