**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE B**' (**read as ACUITE B**) and the short-term rating of '**ACUITE A4**' (**read as ACUITE A four**) to the Rs. 6.00 crore bank facilities of K-Sambhav Powertronics Private Limited (KSPPL). This rating is now an indicative rating and is based on the best available information.

The Uttar Pradesh-based, KSPPL, established in 1996, was promoted by Mr. A.K Raina. KSPPL is engaged in the business of manufacturing of Transformers.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
