**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 6.00 crore bank facilities of K-Sambhav Powertronics Private Limited (KSPPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

The Uttar Pradesh-based, KSPPL, established in 1996, was promoted by Mr. A.K Raina. KSPPL is engaged in the business of manufacturing of Transformers.).

Non-cooperation by the issuer/borrower:
