Mel Systems and Services Limited (MELSS), a Tamil Nadu-based company, incorporated in 1990 provides IT solutions - electronic testing, repair and rework services catering to a host of industries including defence, telecommunication, electronics among others.

For FY2014-15, MELSS reported profit after tax (PAT) of Rs. 0.03 crore on operating income of Rs.26.46 crore, compared with PAT of Rs. 0.83 crore on operating income of Rs.34.70 crore for FY2013-14.
