Acuité has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 14.00 crore bank facilities of Saibaba Solvent Industries LLP. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

The Nagpur based SSI was established in July 2014 by Mr. Santulal Jamtani, Ms. Lata Tajpuriya and Mr. Pradeep Saraogi. SSI is engaged in manufacture rice bran oil and de-oiled cakes and has commenced its commercial operations in February, 2016. The processing capacity stands at around 200 tons of rice bran per day.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
