Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE B+** (read as **ACUITE B plus**)' and short term rating of '**ACUITE A4** (read as **ACUITE A four**)' on the Rs. 5.00 crore bank facilities of P. K. & SONS (PKS). This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Established in 2009, PKS is a Gujarat-based proprietorship firm promoted by Mr. Krunal Patel. The firm is engaged in the construction of roads, railways, highways among others for the public as well as the private sector.

For FY2014-15, PKS registered profit after tax (PAT) of Rs.0.13 crore on operating income of Rs.7.11 crore.
