Rating Rationale

Acuite has downgraded the long-term rating to ‘**ACUITE B**’ (read as **ACUITE B**) from ‘**ACUITE B+**’ (read as **ACUITE B plus**) and reaffirmed the short-term rating of ‘**ACUITE A4**’ (read as **ACUITE A four**) on the Rs. 6.28 Crore bank facilities of MVM PERFECT TOOL MAKERS PRIVATE LIMITED on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.
