## Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B+' (read as ACUITE B plus)** on the Rs.37.00 Cr. bank facilities of Kences Constructions Private Limited(KCPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Kences Constructions Private Limited, part of the Kences Group, was incorporated in 2001 by Mr. K. Narasa Reddy and family. The company is engaged in real estate development and runs 'Fortune Kences', a hotel in Tirupati.

### Non-cooperation by the issuer/borrower:
