Rating Rationale

Acuite has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 10.00 crore bank facilities of Shripati Infrastructures Private Limited. This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower:
