Acuité has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 10.00 crore bank facilities of Shripati Infrastructures Private Limited. This rating is now an indicative rating and is based on best available information.

The Maharashtra based SIPL was incorporated in 2006 by Mr. Yadav and family to undertake civil construction contracts floated by government organisations.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
