Acuité has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and short-term rating of **ACUITE A4 (ACUITE A four)** on the Rs. 7.30 crore bank facilities of Fazil Timbers (FT). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

FT, established in 2005, is a Tamil Nadu-based partnership firm promoted by Mr. S. Mohamed Umare Farook and Ms. L. Fathima Banu. The firm imports timber logs (Teak, Padauk wood and Sal wood) from Australia, Singapore and other African countries and supplies the same to clients in Tamil Nadu, Andhra Pradesh and Karnataka.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
